Report Narrative ON 06/13/04, BILLY RAY DELONG JR. CAME TO THE MCLENNAN COUNTY SHERIFF'S DEPARTMENT. I SPOKE WITH BILLY RAY DELONG JR. AND HE ADVISED ME THAT HE NEEDED TO TELL ME ABOUT WHAT HE HAD DONE TO [REDACTED] AND HE THEN BEGAN TO CRY. I THEN LED HIM TO THE INTERVIEW ROOM AND STARTED THE VIDEOTAPE AND AUDIOTAPE RECORDING. I THEN WENT BACK INTO THE INTERVIEW ROOM AND READ BILLY DELONG JR. HIS MIRANDA WARNINGS. BILLY THEN TOLD ME HE UNDERSTOOD HIS RIGHTS AND SIGNED A WAIVER OF RIGHTS FORM THAT I PRESENTED TO HIM.

I THEN ASKED BILLY WHAT EXACTLY HE WANTED TO TALK TO ME ABOUT. BILLY ADVISED THAT SOMETIME AROUND MARCH OF 2003, HE TOUCHED [REDACTED] WHO IS CURRENTLY SEVEN OR EIGHT YEARS OLD. I ASKED HIM TO EXPLAIN WHERE HE TOUCHED [REDACTED] AND HE TOLD ME ON HER PRIVATE PARTS. I THEN ASKED IF HE WAS TALKING ABOUT HER VAGINA OR ANUS AND HE ADVISED HER VAGINA. BILLY CONTINUED TO EXPLAIN THAT IT ALL STARTED IN MARCH OF 2003 AS A GAME WHERE AT FIRST HE WOULD ONLY TOUCH HER VAGINAL AREA ON THE OUTSIDE OF HER PANTIES. BILLY THEN TOLD ME OVER THE NEXT THREE MONTHS, HE HAD PROGRESSED TO TOUCHING [REDACTED] DIRECTLY ON HER VAGINA UNDERNEATH HER PANTIES. I THEN ASKED IF HE EVER INSERTED HIS PENIS IN HER AND HE STATED, NO. I THEN ASKED IF HE ONLY INSERTED HIS FINGER INSIDE HER VAGINA AND HE TOLD ME, YES. I ASKED BILLY HOW FAR HE THOUGHT HE INSERTED HIS FINGER IN [REDACTED] AND HE SHOWED ME HIS MIDDLE FINGER OF HIS RIGHT HAND AND POINTED TO THE FIRST KNUCKLE JUST BELOW HIS FINGERNAIL, AND SAID "A HALF INCH OR SO." I THEN ASKED HOW MANY TIMES HE HAD DONE THIS TO [REDACTED] AND HE SAID ABOUT FIVE TIMES.

BILLY TOLD ME THAT HE STOPPED DOING THIS TO [REDACTED] IN MAY OF 2003 AND THEN TOLD HIS WIFE CAROLYNN DELONG WHAT HE HAD DONE AS WELL AS AN ELDER AT HIS CHURCH, GEORGE KLINGENSMITH. HE ADVISED THAT GEORGE WAS PRETTY UPSET WITH HIM AND IT WAS DECIDED THAT HE SHOULD MOVE OFF OF THE PROPERTY, WHICH WAS 200 CAUDILL LANE. BILLY ADVISED THAT HE DID PRAY ABOUT THIS WITH HIS WIFE AND MR. KLINGENSMITH AND THEY WERE HOPING BILLY WOULD "BREAK" BEFORE THIS TIME. BILLY DELONG TOLD ME THAT WHEN HE TALKED TO GEORGE ABOUT THIS INCIDENT, GEORGE WAS HOPING BILLY WOULD TURN HIMSELF IN BECAUSE HE DIDN'T WANT TO GET IN TROUBLE FOR KNOWING ABOUT IT AND NOT REPORTING IT. BILLY ADVISED THAT IT TOOK HIM UNTIL THIS DATE TO GET THE COURAGE TO COME FORWARD BECAUSE HE HAS SEVEN KIDS AND HIS OWN FLOOR INSTALLATION BUSINESS AND DID NOT WANT TO LOSE EVERYTHING.

BILLY THEN TOLD ME THAT HIS WIFE'S NAME IS CAROLYNN AND I ASKED HIM WHAT HIS WIFE SAID ABOUT ALL THIS. BILLY ADVISED SHE TOLD HIM SHE LOVED HIM AND THEY JUST PRAYED AND CRIED OVER WHAT HAD HAPPENED FOR A LONG TIME. I ASKED BILLY IF HIS WIFE EVER TOLD HIM TO TURN HIMSELF IN AND HE SAID THAT THEY JUST PRAYED AND WERE HOPING SOMETHING WOULD CHANGE. I ASKED BILLY IF HE NOTICED DURING THE TIME HE WAS TOUCHING [REDACTED] IF SHE WAS INJURED OR IF SHE WAS BLEEDING AND HE SAID NO AND THAT SHE DIDN'T CRY. HE AGAIN TOLD ME THAT HE DIDN'T THINK HIS FINGER WENT INTO HER VAGINA MORE THAN HALF AN INCH. I THEN ASKED BILLY ABOUT [REDACTED] AND WHETHER OR NOT HE HAD EVER TOUCHED THEM. BILLY ADVISED ME THAT [REDACTED]

[REDACTED] BILLY ADVISED THAT HE NEVER HAD [REDACTED] TOUCH HIM AND HE ONLY TOUCHED HER WITH HIS HAND.

I ASKED BILLY WHERE EXACTLY HE WAS LIVING WHEN THIS TOOK PLACE AND AGAIN HE ADVISED CAUDILL DRIVE. HE ADVISED THAT HE WAS PART OF A RELIGIOUS COMMUNITY AT THAT TIME WHICH IS CALLED THE HERITAGE MINISTRIES. BILLY ADVISED THAT ON 08/12/04, GEORGE KLINGENSMITH CAME TO HIS RESIDENCE, WHICH IS CURRENTLY [REDACTED], TO TALK MORE ABOUT WHAT BILLY HAD DONE. BILLY ADVISED THAT GEORGE TOLD HIM THAT HE HAD BEEN LOOKING ON THE INTERNET AND FOUND OUT THAT IT WAS A LAW THAT HE NEEDED TO REPORT WHAT BILLY HAD DONE. BILLY TOLD HIM THAT IT WOULD BE BETTER THAT HE TURN HIMSELF IN INSTEAD OF GEORGE HAVING TO DO IT AND BILLY ADVISED ME HE DIDN'T WANT TO TURN HIMSELF IN BUT DECIDED TO DO IT ANYWAY. HE ADVISED HE DID NOT WANT TO IMPLICATE GEORGE FOR WHAT HE HAD DONE.

I THEN ASKED BILLY TO TELL ME THE NAMES OF [REDACTED]

I THEN ASKED BILLY IF HE HAD ANYTHING ELSE TO DISCUSS WITH ME OR IF HE HAD ANYTHING TO SAY. BILLY SAID TO ME THAT HE WAS JUST SORRY FOR WHAT HE HAD DONE AND AGAIN HE BEGAN TO CRY. I ASKED BILLY WHY HE THOUGHT HE TOUCHED [REDACTED] AND HE ADVISED HE HAD HAD A PROBLEM WITH MASTURBATION SINCE HE WAS VERY YOUNG AND IT HAS BEEN ONE OF THE BIGGEST PROBLEMS FOR HIM TO OVERCOME. I ASKED HIM IF HE AND HIS WIFE HAD BEEN HAVING ANY PROBLEMS AT THE TIME HE TOUCHED [REDACTED] AND HE TOLD ME NO. I THEN ENDED THE INTERVIEW AND STOPPED THE AUDIO AND VIDEO RECORDINGS. THESE TAPES WILL BE PLACED INTO EVIDENCE.

I THEN WENT BACK INTO THE INTERVIEW ROOM ALONG WITH SGT. SMITH FROM PATROL AND BILLY RAY DELONG WAS PLACED UNDER ARREST. I DECIDED TO MAKE A WARRANTLESS ARREST OF BILLY DELONG JR. BECAUSE HE CONFESSED TO A FELONY ON VIDEO AND AUDIO AND I HAD NO TIME TO SECURE A WARRANT. FURTHER, IF I HAD RELEASED HIM IN AN EFFORT TO SECURE A WARRANT, BILLY WOULD HAVE BEEN ABLE TO [REDACTED] SGT. SMITH ASSISTED ME BY TRANSPORTING MR. DELONG TO THE MCLENNAN COUNTY JAIL. ONCE AT THE JAIL I DID FILL OUT A WARRANTLESS ARREST AFFIDAVIT AND THE FORM 6. [REDACTED]

I THEN RETURNED TO MY OFFICE AND I CALLED THE CHILD PROTECTIVE SERVICE POLICE LINE. I SPOKE TO A LADY FROM CPS NAMED MARY WHO HAD EXTENSION 1150. I GAVE HER THE DETAILS OF THIS CASE AND MARY IN TURN GAVE ME A REFERENCE NUMBER OF 30078031. MARY ADVISED ME THAT SHE WOULD MAKE THIS REPORT A PRIORITY. I THEN CONTACTED CAROLYNN DELONG, THE WIFE OF BILLY DELONG. I TOLD HER I HAD ARRESTED BILLY AND [REDACTED] I FURTHER ADVISED HER TO CONTACT ME ON MONDAY 08/16/04 TO MAKE ARRANGEMENTS [REDACTED] AT THIS TIME I HAVE NO FURTHER INFORMATION PERTAINING TO THIS CASE AND ALL NECESSARY PAPERWORK
